



OMMANDERS ADDRESS TO THE DIVISION

Texas Division Compatriots,

One of the highest goals for the Texas Division, Sons of Confederate Veterans these next few months is Heritage Defense. The introduction of a Monument Protection Bill and the protection of Texas Heroes Day Holiday are two priority goals. The Monument Protection Bill needs to be passed with a companion bill in the other house. The Texas Heroes Day Holiday needs to be preserved by defeating the negative bills introduced by both democrats and RINOS.

Michael Hurley is our heritage defense officer, and he is ready, willing and able to lead the battle. Prior years have led to determined efforts by a few brave men and we are proud of the men leading those efforts. If we are to be successful this legislative session, we need to have 46 DEC members walking the halls and knocking on the doors of representatives and senators when we work with the United Daughters of the Confederacy, Texas Society Order of Confederate Rose, and This Is Texas Freedom Force. Numbers make a difference.

Realizing that we cannot get all the brigade officers, command officers, staff, and three past division commanders together all at once on a consistent basis, we need to have strong member support this time. Last session, TX DIV Officers who walked the halls with us were Rob Jones, Michael Hurley, and Shelby Little; they bravely and devotedly walked the maze with Brandon Burkhart of TITFF & Tami Hurley of the UDC to make face to face contact and positive impressions as citizens of their voting districts and organizations. It was something to see our men in action working as a team.

Our plan is to have commander Hurley lead this session's effort in coordinating the volunteer attendees from each brigade each time we work with our allies walking the halls and speaking in front of committees. Our brigade officers should contact each camp commander by phone or in person to make sure that camp commander visits with camp members and he then finds out the strength of each brigade that can be counted on to fight with us in Austin. COS Little has requested, each quarter, that brigade officers send in their quarterly reports with heritage comments. Your quarterly report should include the number of men that each camp can send to the capitol.

We all realize that not everyone can travel to Austin on a moment's notice. We do expect camp commanders to give a volunteer status report in the quarterly reports to brigade, on relative "notice time" to respond to our visits to the capitol. Some committees work on short notice and thus "notice time is often short". (Example: Texas Lonestar Greys, We can send: 1 - man 24 hr. notice, 2 - men 48 hr. notice, 3 - men 72 hr. notice, 5 - men 1 wk. notice) Give us a best estimate number for the men your camp can send to Austin in the fluctuating time frames we might see in committees. Bottom line, we have until Saturday March 4th for the brigades to submit their quarterly reports. Send ASAP.

Our jobs as brigade officers are essential, the division counts on us to do our jobs. Quarterly reports are crucial for this fight. Our fellow compatriots count on us to lead. Michael will be sending out details on how to work with and support him as he leads our heritage defense this session. If you love your Confederate history, fight for it. Since our January 7th meeting, the division has been active in adding new members and rechartering camps. I will leave those details to 2Lt Commander Kyle Sims.

3Lt Cox has been diligently working to improve our membership email address book and rendering great service to the many requests for information to be sent division wide by our commanders and camps. We continue to improve our knowledge of our history and work to become more efficient in our camp operations. The Hico camp recently held a training seminar with great success, both in numbers attending, and content of the training. We should continue to support training and educational seminars in other brigades. We all benefit from a more aware and well researched program of camp training. The seminar also had great participation with input from the members attending. Good job Hico.

A final few comments on the upcoming legislative battles in Austin. We must work as a team, realizing others have talents that we might learn from and improve ourselves. We can only grow and become stronger when we support each other and praise the accomplishments of our compatriots. If you want to improve your Texas division, if you want to improve your self worth, look for the good and positive in your fellow Confederates. Are we making a positive impression with our work ethic, are we raising up our fellow man? If we don't raise the other fellow, who will raise us? We are a brotherhood, call someone in your camp or brigade and thank them for something they have done for you or to help you. You might be surprised at who calls YOU.



Unconventional Times, Unconventional Measures; Partisan Rangers: A Narrative.

The term "partisan ranger" refers to individuals who conducted guerrilla warfare during the War of Northern Aggression on behalf of the Confederacy. Some of the most famous partisan rangers from the Confederate side include John S. Mosby, William Quantrill, and even Nathan Bedford Forrest used this type of warfare to his advantage. Mosby, known as the "Gray Ghost," was particularly successful in disrupting Yankee operations in Virginia and became a legendary figure in Southern lore. Notable partisan rangers include Walter P. Lane and John H. Morgan, who conducted raids behind Union lines.

Walter P. Lane established the First Texas Partisan Rangers for operations west of the Mississippi in June of 1862, less than 2 months after the Partisan Ranger act was passed by the Confederate Congress that April. Rather than the standard 10 company structure, Lane had 14 in total consisting of 600 men who furnished their own supplies such as arms, equipment and horses. Largely successful until the fall of Vicksburg, the First Texas Partisan Rangers consolidated with the Second Texas Cavalry Brigade took part in the Red River Campaign fighting in the battles of Mansfield, Pleasant Hill, Monett's Ferry and Yellow Bayou.

The Partisan Rangers Act was a law passed by the Confederate Congress on April 21, 1862. The act authorized the formation of partisan ranger units, which were essentially irregular guerrilla forces, to fight for the benefit of the Confederacy in hopes it would advance the nation's defense goals.

The act allowed Confederate commanders to grant commissions to individuals who could raise and lead these partisan ranger units with promise of large bounties.

The rangers were authorized to operate behind enemy lines and conduct raids, sabotage, and reconnaissance missions against Federal forces. They were also encouraged to disrupt Union supply lines and communication networks.

The Partisan Rangers
Act was controversial, as
some Confederate leaders
feared that it would lead
to undisciplined and
uncontrollable forces, while
others saw it as a way to
counter Union advantages
in conventional warfare.

What made Partisan Ranger battalions special was their unique structure and tactics. They were typically composed of mounted infantry who were able to move quickly and strike at enemy targets with surprise attacks.

Partisan Rangers were not subject to the same rules of engagement as regular army units and were often granted more autonomy and freedom to conduct unconventional operations. They were authorized to operate independently and to use tactics such as ambushes and hit-and-run attacks to disrupt enemy operations.

The success of Partisan Ranger battalions led to their widespread use throughout the Confederate Army, and they played an important role in the Confederate war effort. However, their unorthodox tactics and lack of formal training also made them difficult to control and at times led to abuses against civilians. The use of Partisan Ranger battalions was controversial both during and after the war, and their legacy remains a subject of debate among historians.

Partisan Rangers were identified in the field by a number of distinctive features:

Clothing: Partisan Rangers often wore civilian clothing or a mix of civilian and military clothing, which helped them to blend in with the local population and avoid detection.

Weapons: Partisan Rangers were typically armed with a mix of weapons, including rifles, shotguns, pistols, and knives. They often carried multiple weapons and were skilled at using them in close-quarters combat.

Horses: Partisan Rangers were mounted infantry and relied heavily on their horses to move quickly and evade pursuit. They often rode fast, agile horses that were trained for combat.

Flags: Some Partisan Ranger units carried distinctive flags or banners that identified them as Confederate forces.

Tactics: Partisan Rangers were known for their unconventional tactics and guerrilla warfare tactics, such as ambushes and hitand-run attacks. They often operated in small groups and were able to strike quickly and disappear into the surrounding countryside.

Ethnicity: Partisan
Ranger units could be
diverse. Comprised of
different races and creeds,
many able to speak in
different languages, these
irregular militiamen could
easily blend in with the
community being Black,
White, Hispanic, or Native
American so as to not draw
unnecessary or unwonted
attention.

Report of the First Lt. Commander Texas Division Executive Council Meeting, Waco, TX March 4, 2023

<u>88th Texas Legislature Update</u> As of the writing of this report, the Texas Legislature has now been in session for 54 of the 140 days. The 88th legislative session began January 10, 2023 and is scheduled to end May 29, 2023. We have several bills before the Texas House and the Texas Senate.

MONUMENT PROTECTION - House Bill 650 sponsored by Representative Stephen Allison. This bill is pro protection of historical monuments with criminal penalties for damage to public monuments.

REMOVAL OF CONFEDERATE HEROES DAY AS A STATE HOLIDAY - Senate Bill 91 by Senator Nathan Johnson (D-Dallas), House Bill 599 by Matt Shaheen (R -Plano) House Bill 51 by Representative Jarvis Johnson (D -Houston) All three bills have been referred to the House or Senate State Affairs Committee.

The Senate Affairs Committee is chaired by Bryan Hughes (R -Tyler) The House Affairs Committee is chaired by Todd Hunter (R -Corpus Christi).

We have been closely monitoring both State Affairs Committee agendas. So far none of these bills have been placed on an agenda by either committee.

I will be in Elm Springs attending the GEC meeting today (March 4) and I will be asking the 1st Lieutenant Commander of the SCV for permission to use the "one click" email system the National leadership has in place to contact your State Representative and State Senators to make your voice heard on these bills. Watch the Texas Division Email system for upcoming details.

I will also be communication to you via the Division Email system the day and times we will need your presence in Austin TX.

Monument Protection Issues in Texas.

GEORGETOWN TX - The lawsuit against the Williamson County Grays Camp #502 is an ongoing litigation that continues to make it's way through the court system. Chief

of Staff Little will have a full report concerning the latest details at our meeting.

GAINESVILLE TX - The Confederate monument located in Gainesville TX was removed from it's place of honor by the City of Gainesville in 2020 has been returned to the Texas Division United Daughters of the Confederacy. The monument has now been moved to Fort Chadbourne located in Brontë TX. The rededication of the monument will be held at Ft. Chadbourne on Saturday, March 18, 2023.

After sending my email I received a phone call from Susan's husband, and he advised that we would be accepted into the Festival. The lesson to be learned here is, don't always take a 'No for an answer until you use up all of your other options. Sometimes it takes a little convincing.

Sad news, about Celtic festivals. The Texas Scottish Festival held every year in May in Decatur, Tx. has been cancelled. There are some things in the works about possibly continuing the festival through some other avenues. We will keep you posted if anything develops.

I am enclosing my email that turned a "No" to a "Yes" for us concerning the Celtic Festival in Grapevine. Please review so you can get some indication on how to present our organization to people who don't know much about us.

"Dear Susan, I received a message that Sean Partee our camp Commander of Brigadier General Richard M. Gano camp of Grapevine, Tx that we were not accepted to participate in the upcoming Celtic Festival in Grapevine due to the festival being Celtic themed.

If I may, I wanted to explain our past experiences with festivals such as this. For many years we had a booth at the North Texas Irish Festival in Dallas. We have participated many years at the Texas Scottish Festival currently being held in Decatur, Tx. We are still involved in this festival by doing the opening ceremonies gun salute. Many of our members wear kilts and belong to various Scottish clans. I personally belong to Clan Fraser.

You may contact any of representatives of the Texas Scottish Festival that have welcomed us for many years. We also provide volunteer work for many of the activities to assist the festival such as ticket booth, VIP service, etc.

Many years ago, I thought to myself how we could honor the many veterans who served in the War Between the States, which many descended from Celtic blood. Did you know General Robert E. Lee is a direct descendant of Robert the Bruce? General Stonewall Jackson was also of Scottish descent.

Our booth consists of many flags with Celtic history. The Hardee flag is the "Celtic Moon," Many other flags consists of the St Andrews Cross. We use the 10th Tn. Inf. flag which has the Irish Harp. The Gen. R. E Lee headquarters flag. As you can see, the Confederate Army was very much influenced by their Celtic heritage.

Also, we have a collection of books to show the public how much of the Confederate Army was made up of the Scotch/Irish people. One of the most respected Generals who died during the war was an Irish General named Patrick Cleburne. We have books on him for display. We have books on the Irish regiments from Tennessee and Georgia.

Our camp marches in the Veterans day parade held in Grapevine every year. We have performed a gun salute to open up the parade which excites the crowd. As you can see, we will always be an asset for any functions we participate in.


3rd Lt. Commander Report


Traffic Overview For 30 Days (February 2023)



Five Simple Rules For A Successful Camp

Over the years, I have been blessed to travel all over our great state, speaking to SCV Camps. Some camps were struggling, and others were thriving. What made the difference? The truth is there is no "secret sauce" that is ironclad regarding camp growth and stability. Each Camp is as unique as the men in its membership. However, most stable, growing, and happy Camps generally share similar qualities.

Based on my observations, here are 5 Simple Rules for Having a Successful Camp.

- **1.** A Busy Camp Is A Happy Camp giving each member a task in the work of the Camp is essential (especially for new members) if you want to create a connection within the membership. These opportunities to serve in the Camp should be a priority for every Compatriot. Too often, the camp commander is the primary member doing everything from setting the room up for the meeting to bringing camp flags, etc. Delegate duties to the membership, even if they might not do as well as you do. Delegation is essential to creating relationships, and relationships should be a top priority of the local Camp. Friendships within the Camp strengthen and create a more dedicated membership.
- **2. Help Those Who Are Struggling** Some of the longest-lasting relationships are cemented when someone is facing adversity. I recommend a personal phone call or face-to-face meeting, but even a heartfelt text at the right moment can make a difference. I called a Compatriot not long ago who was discouraged and feeling overwhelmed and unappreciated. I reminded him of his value and showed him an appreciation for his years of service to the SCV. In short, show people you care; the Camp will see the dividends in time.
- **3. Handwrite Thank You Notes** a handwritten note impacts today's email and text message world. A handwritten note is so rare today that they are ALWAYS read. A simple card to a potential member, a note of thanks for the work of a Compatriot, has an impact. Don't overlook this simple act that reflects the investment of your time, genuine concern, and recognition of others.
- **4. Curb Your Potty Mouth** Society is so casual today that foul language is widely accepted. Sometimes, letting loose with a few choice words can feel satisfying. But the truth is that it is a reflection of your heart. It is an expression of your inability to express yourself with your vocabulary, and often leaves a bad impression on potential new members.
- **5. Learn To Say You Are Sorry** This is a true struggle for many, precisely why it is such a powerful relationship maker. Saying sorry does not mean losing the argument or yielding to those who you disagree. Saying you are sorry means you are the bigger person. You are willing to lay your ego aside to build a relationship, a camp, and our division.

What sets your Camp apart from others? <u>In the end, it is YOU!</u> Always be cognitive of being the kind of person, the kind of friend, and the kind of man you would want to have in your Camp. Oh, and one more simple rule... don't forget to SMILE:)

The nature of the meeting is to elect Division Officers and vote on proposed amendments to the Division Constitution.

The 2023 Texas Division Reunion, otherwise known as the annual convention, will be held in Lubbock Texas at the following time and location.

Proposed Amendment to the Texas SCV Division Constitution and By-Laws: Texas SCV Division Annual Convention, June 3, 2023

REASON for proposed change: This is not addressed in the current Constitution and establishes semi-annual, i.e. "twice a year" meetings Brigade Meetings are held in addition to the Division Convention Meeting. **Prohibitions**

Move 12.6 to 12.8

12.6 No member, camp or brigade of the Texas Division Sons of Confederate Veterans will engage in any type of social media, personal or otherwise.

12.6.2 Should any member of the Texas Division be in violation article 12.6.1 it shall be considered an actionable offense as defined in General Constitution 13.1

Rationale: To prevent opposition from obtaining data and information on any of our camps and membership, social media should be avoided entirely. Anything risqué posted to a personal profile reflects the integrity of the membership of our organization. It should be mentioned that fake names go against social media company's Terms of Service. Digital Newsletters also fall within the category of a "Social Medium" since they are accessible to the public. This bylaw is intended to prevent account Impersonation/ Cloning; Doxing; Our level of professionalism drops dramatically when we have camp members that make public posts (including but not limited to camp pages) containing many misspellings and grammatical errors.

12.7 Use of personal email for Texas Division and SCV Business is prohibited. Each camp should have email addresses for each role established that can be transferred to new officers upon elections or appointments. Data will not be erased, deleted or destroyed but preserved for posterity.

12.7.2 Should any member of the Texas Division in violation article 12.7.1 it shall be considered an actionable offense as defined in General Constitution 13.1

Rationale: To prevent opposition from obtaining data and information on any of our camps and membership, an encrypted email network is a necessity. Camp officers should have access to any and all emails that regard camp business no matter who sent it and when. With membership dying and passwords being lost or widows not giving access to these personal emails, we are effectively losing data and SCV history. A Division controlled network would give our leadership all access to internal documents. This bylaw is intended to help prevent spoofing, phishing and hacking of our membership as well.



Overall, Partisan Rangers were identified more by their tactics and behavior than by any specific uniform or insignia. Their ability to operate effectively behind enemy lines and to avoid detection made them a formidable force and a significant challenge for Union forces during the War Between the States.



Arguably the greatest Partisan Ranger

As of February 1864, the Partisan Ranger act was repealed due to the efforts of Robert E. Lee who preferred a more honorable and conventional means of warfare. Under the laws of war, unconventional combatants were not considered soldiers. The tactics of these irregular fighters struck fear into the hearts of the enemy uncertain when or where the Confederates would next attack. Although unconventional, legends were made and through literature, music, television and film, these legacies live on even to this day.

Christian Lee is an amateur historian who has produced dozens of lectures and documentaries on southern history. He is a 6 year member of the Sons of Confederate Veterans - Alamo City Guards Camp 1325 and also its commander.
